**AMENDED ORDER GRANTING  
STIPULATED MODIFICATIONS  
OF SETTLEMENT TERMS [418]**

1 This Court, having considered whether to grant the stipulated  
2 modifications of settlement terms of the above-captioned action pursuant to the  
3 Joint Stipulation Re: Modification of Settlement Terms, having read and  
4 considered all of the papers and argument of the parties and their counsel, and  
5 good cause appearing,

6 **IT IS ORDERED AS FOLLOWS:**

7 1. The provision of services under the Jobs and Education and the  
8 Tattoo Removal Programs shall be extended by six months to December 27,  
9 2021.

10 2. The Claim Forms shall be amended to reflect that:

11 a. the deadline for receipt of claims is June 27, 2021;

12 b. the provision of services under the Programs will continue  
13 until December 27, 2021.

14 3. The [Proposed] Second Amended Claim Form filed as Exhibit 2 to  
15 the Joint Stipulation Re: Modification of Settlement Terms, is approved.

16 4. Within 21 days of the approval of this stipulation, and entering of this  
17 Order, City shall cause the approved Second Amended Claim Form to be served  
18 by mail to all Settlement Class Members at the last known class member addresses  
19 which the City has updated since 2017.

20 5. City shall provide a Second Amended Claim Form to any Settlement  
21 Class Member who requests one.

22 6. Class Counsel shall post the Second Amended Claim Form to  
23 download at [www.gangcase.com](http://www.gangcase.com) for the duration of the injunctive relief following  
24 court approval of the Second Amended Claim Form. Class Counsel also shall  
25 provide a Second Amended Claim Form to any Settlement Class Member who  
26 requests one.


