**ORDER APPROVING  
STIPULATED MODIFICATIONS  
OF SETTLEMENT TERMS [428]  
[430]**

This Court, having considered whether to grant the stipulated modifications of settlement terms of the above-captioned action pursuant to the Fourth Joint Stipulation Re: Modification of Settlement Terms, having read and considered all of the papers and argument of the parties and their counsel, and good cause appearing,

**IT IS ORDERED AS FOLLOWS:**

- 1. The provision of services under the Jobs and Education and the Tattoo

1 Removal Programs shall be extended by a further twelve months to June 27, 2023;

2 2. The Claim Forms shall be amended to reflect that:

3 a. the deadline for receipt of claims is March 27, 2023;

4 b. the provision of services under the Programs will continue until June  
5 27, 2023;

6 3. The [Proposed] Fifth Amended Claim Form filed as Exhibit 5 to the Fourth  
7 Joint Stipulation Re: Modification of Settlement Terms, is approved.

8 4. Within 21 days of the approval of this stipulation, and entering of this Order,  
9 City shall cause the approved Fifth Amended Claim Form to be served by mail to all  
10 Settlement Class Members at the last known class member addresses.


11 5. City shall provide a Fifth Amended Claim Form to any Settlement Class  
12 Member who requests one.

13 6. Class Counsel shall post the Fifth Amended Claim Form to download at  
14 [www.gangcase.com](http://www.gangcase.com) for the duration of the injunctive relief following court approval of  
15 the Fifth Amended Claim Form. Class Counsel also shall provide a Fifth Amended  
16 Claim Form to any Settlement Class Member who requests one.

17 7. The Claims Administrator shall continue to receive and process all claims  
18 submitted by Settlement Class Members pursuant to the joint written instructions  
19 provided by Class Counsel and Defense Counsel.
